We further undertake to pay you the charges and/or fees incurred in connection with the collection/negotiation/discount hereunder at the rate prescribed by you from time to time and to hold you free and harmless from and against all expenses, losses and damages howsoever incurred and/or may be incurred to you in consequence of your collection/negotiation/discount of the above mentioned draft(s) and/or documents, including but not limited to attorneys' fees and/or legal expenses paid or incurred by you in connection with the claim in respect of the said draft(s) and/or documents, in which case we agree to fully indemnify you immediately upon our receipt of your notice to that effect.
- 4. We hereby agree that this will serve as your authority to charge our account with the amount of the draft(s) and/or documents or, in case the draft(s) and/or documents are in a foreign currency, the Baht amount equivalent of the draft(s) and/or documents amount at the then prevailing bank's selling rate, including interest and all other costs and expenses.
