Terms and Conditions

- The Applicant consents and acknowledges that this Application is made for the purpose of submitting the E-mail Instruction to amend and confirm the details specified in the draft of the Letter of Credit and/or Domestic Letter of Credit issued upon the Applicant's request under Krungsri Tradelink System (hereinafter referred to as the "Request") to the Bank prior to issuing Letter of Credit and/or Domestic Letter of Credit, provided that important details, including but not limited to the beneficiary's name and the amount of the Letter of Credit and/or Domestic Letter of Credit, cannot be amended in accordance with the method hereunder.
- The Applicant consents and acknowledges that the Applicant has directly submitted the Request via Krungsri Tradelink System approved by the Applicant's authorized person prior to submitting the E-mail Instruction under this Application.
- The Applicant consents and acknowledges that the Bank shall, without any obligations, perform as per the E-mail instruction received from the Applicant's User via the Applicant's E-mail Address as specified above and the Bank may, at any time, refuse to process the E-mail Instruction as it deems appropriate.
- The Applicant consents and acknowledges that the Bank shall process the E-mail Instruction under the terms and conditions specified herein and regard that the E-mail Instruction provided to the Bank as being consented to by the Applicant's authorized person without informing to or obtaining any additional consent from the Applicant.
- The Applicant consents and acknowledges that the E-mail Instruction sent to the Bank shall be considered when it reaches the Bank during its normal business hours. The Bank shall, at its discretion, process the E-mail Instruction received under this Application during its normal business hours, depending on the time of receipt.
- The Applicant consents and acknowledges that the E-Mail Instruction submitted via the Applicant's E-mail Address by the Applicant's User under this Application that has already been processed by the Bank shall be deemed accurate and valid and shall bind the Applicant as if the E-mail instruction is submitted and approved by the Applicant's authorized person. The Applicant further agrees that such E-mail Instruction may be used as evidence to prove that the Applicant has performed the E-mail Instruction and used in legal proceeding against the Applicant and agreed to be liable for those action as if they had been performed by the Applicant.
- The Applicant agrees and accepts that the Bank is not able to authenticate the Applicant's User who sends the E-mail Instruction via the Applicant's E-mail Address. The Applicant agrees to be responsible for any transaction conducting by the Bank according to the E-mail Instruction received from the Applicant's E-mail Address.
- The Applicant consents and acknowledges that should there is any change to the Applicant's E-mail Address and/or the Applicant's User as specified above, the Applicant must submit to the Bank the new Application. Upon the Bank's receipt of the new Application, it shall be deemed that such new Application shall supersede the original Application immediately.
- The Applicant consents and acknowledges that the Bank shall not be responsible in any respect for delay in receiving the E-mail Instruction or failing to receive the E-mail Instruction, and is neither liable nor responsible for damage, claims, or any expenses incurred to the Applicant due to the Bank's compliance or failure to comply with the E-mail Instruction received by the Bank.
- The Applicant agrees to indemnify and hold harmless the Bank from and against any and all liabilities, claims for damages, actions, damages, any claims and costs which may incur to the Bank, including all legal costs or any other expenses sustained by the Bank for a reasonable cause due to the Bank's processing of or refusal to process the E-mail Instruction provided by the Applicant to the Bank hereunder. The indemnification in this clause shall be deemed as supplemental to any other indemnification or security for damage provided by the Applicant to the Bank.
- Where the Applicant has provided to the Bank personal data of any other person: (a) the Applicant undertakes to verify the accuracy and completeness of such person's personal data provided by the Applicant to the Bank, and to notify the Bank of any change to person data provided; (b) the Applicant warrants that the Applicant has obtained consent or can rely on other legal basis for the collection, use, disclosure and/or transfer of such personal data in compliance with applicable laws; (c) the Applicant warrants that the Applicant has informed such person of the Bank's privacy notice; and (d) the Applicant warrants that the Bank can lawfully collect, use, and further disclose and/or transfer of such personal data for the purposes set out in the Bank's privacy notice (as may be amended from time to time), including the purposes set out in this Application.
